Consent

No one except riders officially entered in the event may ride or practice on any portion of the track during a club event. All appropriate waivers must be fully signed prior to riding the track. All riders must hold a valid ABA license at all times and may be required to prove verification. All riders must wear the appropriate safety equipment consisting of long sleeved shirt, long pants, gloves, closed toe shoes and full-face helmet while on the track. Number plates must be clearly visible and secured on all bikes. All riders must ensure that their bike is in safe condition prior to being permitted to operate the bicycle on the track. An inspector may determine that the bikes is unsafe, if this occurs, the rider will not be permitted to use the facility until the bike is fixed and approved by an inspector.

If the rider is under 18 years old, both rider and parent/legal guardian signatures are required.
